**ARTICLE IV

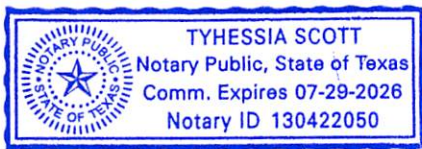
